## On the Offensive

- FDIC special assessment exemption for banks under \$5B in assets
- Injunctive relief from the CFPB's 1071 rulemaking & CRA rules implementation
- Pro-community bank bills advance supporting reg relief, cannabis banking, de novo formation, credit applicant privacy, workable exam appeals, CDFIs, and more
- Pro-community bank bills block U.S. CBDC creation and restrict sale of "trigger leads"






